For the interim period ended 30 June 2023

1 General information

Asphere Innovations Public Company Limited (Formerly Asiasoft Corporation Public Company Limited) ("the Company") is a public company limited incorporated and resident in Thailand. The address of the Company's registered office is 51 Major Tower Rama 9 - Ramkhamhaeng 18tfeh floor, Room No.3-8, Rama 9 Road, Hua Mak, Bangkapi, Bangkok.

The Company's ordinary shares are listed on the Stock Exchange of Thailand. For reporting purposes, the Company and its subsidiaries are referred to as "the Group".

The Group is principally engaged as a provider of online game services.

This interim consolidated and separate financial information was authorised for issue by the Board of Directors on 11 August 2023.

This interim consolidated and separate financial information has been reviewed, not audited.

2 Accounting policies

Basis of preparation

The interim financial information has been prepared in accordance with Thai Accounting Standard 34 Interim Financial Reporting. The primary financial information (statement of financial position, comprehensive income, changes in shareholders' equity and cash flows) is presented in a format consistent with the annual financial statement complying with Thai Accounting Standard 1 Presentation of Financial Statement. The notes to the financial information are prepared in a condensed format. Additional notes are presented as required by the Securities and Exchange Commission under the Securities and Exchange Act.

The interim financial statement should be read in conjunction with the annual financial statement for the year ended 31 December 2022.

An English version of the interim consolidated and separate financial information has been prepared from the interim financial information that is in the Thai language. In the event of a conflict or a difference in interpretation between the two languages, the Thai language interim financial information shall prevail.

The accounting policies used in the preparation of the interim financial information are consistent with those used in the annual financial statement for the year ended 31 December 2022.

New and amended Thai Financial Reporting Standards effective for the accounting periods beginning on or after 1 January 2023 do not have material impact on the Group.

3 Estimates

The preparation of interim financial information requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets and liabilities, income and expense. Actual results may differ from these estimates.

In preparing this interim financial information, the significant judgements made by management in applying the Group's accounting policies and the key sources of estimation uncertainty were the same as those that applied to the consolidated and separate financial statement for the year ended 31 December 2022.

4 Operating segments

The Board of Directors is the Group's chief operating decision-maker. Management has determined the operating segments based on the information reviewed by Board of Directors for the purposes of allocating resources and assessing performance.

The Board of Directors considers the business from both a geographic and product and service perspective. Geographically, management considers the performance in Thailand, Singapore, Malaysia, Vietnam and other countries. From a product and service perspective, management separately considers the online game services and distribution activities in these geographies. The Group derives their revenue primarily from the online game services.

The Board of Directors assesses the performance of the operating segments based on a measure of adjusted EBIT. This measurement basis excludes discontinued operations and the effects of non-recurring expenditure from the operating segments such as restructuring costs, legal expenses and goodwill impairments when the impairment is the result of an isolated, non-recurring event. The measure also excludes the effects of equity-settled share-based payments and unrealised gains (losses) on financial instruments. Interest income and expenditure are not allocated to segments, as this type of activity is driven by the central treasury function, which manages the cash position of the Group.

Income between segments are carried out at arm's length. The revenue from external parties reported to Board of Directors is measured in a manner consistent with that in the statement of comprehensive income.
